Feb. 4 Waterview (Rowlett) 972-463-8900; 9509

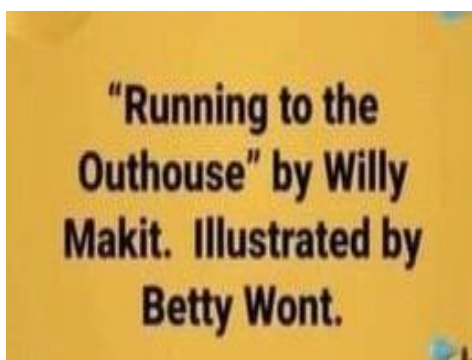
Waterview Pkwy. Drive the Geo. Bush Turnpike east through Garland, past Hwy 78/past the Firewheel Mall.

Exit at Merritt/Liberty Grove Connector. At 2nd stop sign (Liberty Grove), turn left. Drive 1.7 miles. Turn left at Waterview Pkwy, leads to golf course on left. If driving through downtown Dallas on I-30, proceed east of LBJ Frwy (635), Garland, and exit at Geo Bush Turnpike (north). Exit the Turnpike at Lakeview Pkwy/Main St. /Hwy 66. Stay on the Service Road, passing Main St., passing Hwy 66 for another 1.4 miles. Turn right at the stop sign (Liberty Grove). Drive 1.7 miles. Turn left at Waterview Pkwy, leads to golf course on left.

Feb. 11 Country View (Lancaster) 972-227-0995; 240 W. Belt Line Rd. Drive I-35E south, thru downtown Dallas. Continue 7 miles past Reunion Tower, exit at Belt Line Road, turn left, drive 4 miles, course entrance on right.

Feb. 18 Irving G.C. (Irving) 972-457-0772 2000 E. Shady Grove Rd. Drive I-35E, bear right to get on Loop 12 South towards Irving. Pass Hwy 183 and drive 2 ½ miles south. Exit at Shady Grove, turn left, course entrance on right.

Feb. 25 Tenison Park (Highlands) (Dallas) 214-670-1402; 3501 Samuell Blvd. Drive east of downtown Dallas on I-30, exit at Dolphin Rd., turn left, under I-30 for 1 block, right turn on Samuell Blvd. Then a left turn at Tenison Parkway, course entrance on right.

Examination of financial assets (ending fiscal 2025) of NTSGA reveals the following:

Total assets of the Association: \$40,433

Assets owed to members (Bank): \$36,484

NTSGA net worth (Dec.): \$ 3,949

I am comfortable with assessing member's \$60.00 annual dues for 2026 and also keeping the tournament fees at \$60.00...includes \$10 prize fee, for the first 4 months of 2026. In light of golf course green fees increasing from 2025 at many of our tournament sites, the Board of Directors will re-convene in April to determine if an increase in tournament fees is warranted for the balance of 2026.
